Agenda 1: Confirmation of the Minutes of Ninth EC Meeting held on April 7, 2021 and **Action Taken Report**

- Dr Anuradha Agrawal, General Secretary, welcomed the EC members and thanked them for their presence.
- Dr R.C. Agrawal, Vice President, was felicitated by the ISPGR for being bestowed with the prestigious Rafi Ahmed Kidwai Award 2020 by ICAR on July 16, 2021. ISPGR also placed on record appreciation for two other members of ISPGR, namely Dr OP Yadav for being bestowed with Rafi Ahmed Kidwai Award 2020 and dr G.J. Randhawa for getting DR Panjabrao Deshmukh Outstanding Women Scientist Award 2020.
- The minutes of the Ninth EC Meeting held on April 7, 2021 were confirmed.
- Thereafter, the ATR report was presented by the General Secretary (Annexure 2).
- It was suggested that proceedings of brainstorming meeting on "Digital Sequencing Information and ABS" should be printed (500 hard copies), so that it can be shared with participants of GB9 meeting of the ITPGRFA, scheduled in Delhi. For printing the hard copies, sponsor(s) could possibly be identified from seed companies who participated in the meeting.

Agenda 2: General Secretary's Report

- Dr Anuradha Agrawal presented the General Secretary's report (*Annexure 3*).
- Dr R.S. Paroda advised that GS take proactive role in the IAC2021 preparation with respect to invitation from Congress Secretariat to Indian speakers, co-organizers etc. Further, inputs should go to Rome Declaration by circulating the document amongst ISPGR EC members.

• The ISPGR award function for 2019 and 2020 to be organized on 7th August, 2021 in hybrid mode (physical and virtual mode).

(Action: General Secretary and Joint Secretary)

• It was decided that Dr Dilbag Singh Athwal Memorial lecture and General Body Meeting of ISPGR may be organized on August 27, 2021. Information to be circulated accordingly.

Agenda 3: Editor-in-Chief's Report

- Dr Sunil Archak presented the EIC's report (*Annexure 4*). He apprised the status of manuscripts, and printing of IJPGR.
- For inclusion of the IJPGR in UGC care list, follow-up with NAAS was suggested for Editor-in-Chief. A letter from President, ISPGR to President, NAAS in connection with UGC care list inclusion was suggested.

Agenda 4: Treasurer's Report

- In the absence of Dr Dinesh Kumar, Treasurer's Report was presented by the GS (*Annexure* 5).
- It was decided that based on verification by the Charted Accountant, the money should be returned to BISA, on account of excess payment for IAC2016.

Further, invitation to specific institutes could go and Zonal Councillors and Joint Secretary could proactively coordinate the activity. (Action: Joint Secretary & Zonal Councillors)	Action pending due to COVID pandemic lockdown during April-June 2021. This action will be pursued now onwards.
2.	President advised that proceedings of National Webinar on "Virtual Brainstorming on Digital Sequence Information and Germplasm Sharing'," held on March 1, 2021, be expedited and uploaded on ISPGR website. (Action: General Secretary)	Draft is ready. Final version is expected to be completed by end of July, 2021.
3.	President advised ISPGR EC to take a proactive role and suggest suitable names for various committees, identify suitable leading topics along with scientists from India who could be invited as speakers. (Action: General Secretary and Editor-in-Chief)	Needful has been done
4.	The President appreciated work done by EIC, Editors, Reviewers and ISPGR staff in journal updating and congratulated all for increase in NAAS rating (from 5.12 to 5.54). With regard to UGC Care list, he suggested that the matter may be taken up with NAAS in writing to have the issue resolved. (Action: Editor-in-Chief)	Matter communicated to NAAS
5.	It was urged that checking of accounts of IAC2016 by Charted Accountant of ISPGR be expedited to settle that matter with BISA at the earliest. 8.	It was suggested that ISPGR award function be held in May, in virtual or hybrid mode, along with General Body Meeting of ISPGR. It was also agreed by EC members that awardees of HB Singh Award, Barwale Award and RS Paroda Award make brief presentations of their achievements during the ISPGR Award function, provided time permits. (Action: General Secretary & Treasurer)	Due to lockdown , Award function is planned in mid August, along with GBM.
9.	Dr R.S. Paroda President suggested that visibility of Society be increased by improving its website, printing new brochure/flier and increasing membership drive. (Action: General Secretary and Joint Secretary)	New website template is ready. Data entry will be completed soon. Can be launched at next ISPGR function/event.

2nd International Agrobiodiversity Congress (IAC 2021)

- The GS apprised the EC on the preparations of the 2nd International Agrobiodiversity Congress (IAC 2021) scheduled from Nov. 15-18, 2021, as a Virtual Congress. The theme of the Congress is 'Transforming food systems and delivering on the 2030 Agenda for Sustainable Development through the use and conservation of agrobiodiversity' and ISPGR is one of the partners in its organization.
- Dr R.S. Paroda, President, ISPGR, invited as Member of International Advisory Board of 2nd IAC; Dr Anuradha Agrawal, nominated by ISPGR to be Member of International Steering Committee (ISC) and Communication Committee (CC) of IAC2021.
- As a member of the ISC, the GS attended three meetings (April 1, May 26, June 23, 2021) with the Congress Secretariat. One meeting as member of CC was also attended on June 9, 2021. Details about program and inputs from ISPGR were shared with the EC members., besides the details about the governance, themes and structure of the 2nd IAC.
- It was informed that IAC2021 website (https://www.eatgrowsave.org/) was recently made live and ISPGR logo included in it.
- On the inaugural day, Dr R.S. Paroda shall be invited for giving an overview on the 1st Agrobiodiversity Congress, and Dr T. Mohapatra, DG ICAR shall be giving a talk on the follow up action on the Delhi Declaration on Agrobiodiversity Congress. Dr Kuldeep Singh, Vice-President, ISPGR, shall be the Co-Convenor for the session on ex situ conservation.
- Names of scientists have been provided from ISPGR/NBPGR/other institutes for three scientific sub-committees (consumption, production, and conservation) to help in selection of abstracts. Call for abstracts was closed on July 7, 2021 and 638 abstracts received.
- A side event by ISPGR was earlier proposed on the topic "Agricultural biodiversity for diversified and sustainable food systems: Current status and preparedness for post-2020 Global Biodiversity Framework".
- EC members were informed about 'Rome Declaration' which builds on the Delhi Declaration, to be adopted in the IAC 2021. This document is in draft mode and circulated amongst partners for providing inputs.
