Agenda 1: Welcome Remarks

• At the outset, Dr Anuradha Agrawal, General Secretary, welcomed the Chairman, all the members of Executive Council (EC) and General Body (GB) present physically as well as through online mode.

Agenda 2: Introductory Remarks by Chairman

- While welcoming all GB members, Dr R.S. Paroda, congratulated all those who received their awards in a function held in the forenoon. He also placed on record his appreciation to the members of Award Selection Committee, comprising Dr S.K. Vasal (Chairman), Dr R.C. Agrawal (Member), Dr. G.P. Singh (Member), Dr. Viswanathan C.(Member), Dr Malavika Dadlani (Member) and Dr Anuradha Agrawal (Member Secretary) for sparing their efforts in selecting the most deserving candidates. He also appreciated the efforts of General Secretary for her meticulous planning to organise the award function.
- He also apprised the members about various activities carried out successfully

during the year 2022-23. These being: the National Symposium on 'Food, Nutrition, Health and Environmental; Security: Aiming to Achieve SDGs (August 29-30, 2022), 1st National Conference on Plant Genetic Resources Management (NCPGRM) (November 22-24, 2022), and participation of ICAR-NBPGR and ISPGR in the 9th Governing Body Meeting (GB9) of the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA) (September 19-24, 2022).

- He appreciated the efforts made by Dr Sunil Archak, Editor-in-Chief (EIC) and also by the committee constituted for elevating the stature of IJPGR under the chairmanship of Dr R.K. Tyagi, for online publication of IJPGR through MRI Publishers. He expressed satisfaction on the timely publications of journal and other Society publications of high quality.
- Dr Paroda emphasized the need for increasing the number of life members. For increasing the membership, members of other related Societies and PGR students have to be approached.

Agenda 3: Confirmation of Minutes of 12th GBM, Action Taken Report (ATR) and Progress Report of ISPGR

- The minutes of the 12th GBM held on August 20, 2022 were unanimously confirmed and ratified by the GB.
- Dr Anuradha Agrawal, General Secretary, presented the ATR report on the 12th GBM (*Annexure 3*), followed by progress report of ISPGR since the last GBM (*Annexure 4*).
- All participants were appreciative of different activities and thanked the General Secretary for her sincere efforts.

Agenda 4: **Progress of IJPGR by Editor-in-Chief**

- Dr Sunil Archak, Editor-in-Chief, presented the report related to publication of IJPGR (*Annexure 5*). He apprised the status of manuscripts, and as well as printing schedule and progress, NAAS rating of the Journal, citation in Google Scholar *etc*.
- The new online publication portal of IJPGR through MRI Publishers was exhibited to all GB members. All members present were appreciative of progress made towards improving the quality and rating of our journal.
- The issue of seeking publication charges for papers submitted to IJPGR was discussed. It was deferred with a recommendation that the same may be discussed and approved later once the NAAS Score of the IJPGR goes above 6.0 point.

• It was recommended by the GB that fresh consent be sought from Foreign Editors of IJPGR to continue their tenure based on their active and timely trview. Also, it was agreed that some new foreign editors be invited in order to improve the visibility and impact of IJPGR.

(Action: EIC, IJPGR)

- The President appreciated the work done by EIC, Editors, Reviewers and ISPGR staff for timely publication of the journal.
- Dr S.K. Vasal suggested that a special issue of IJPGR may be published for the effective utilization of PGR through public-private partnership. The President also endorsed this view and suggested that an interphase meeting with private sector may be planned in collaboration with ICAR-NBPGR to understand the expectations of private sector from the Society (ISPGR) specially with regard to access-benefit sharing and the resource generation.

Agenda 5: Financial Report of ISPGR by Treasurer

- Dr Sanjeev Kumar Singh, Treasurer, presented financial status of ISPGR, including the audited reports for the FY 2022-23 (*Annexure 6*).
- The members were pleased to note quite healthy financial position of the society and placed on record their appreciation for EC to build the reserve for future sustainability of the Society. President also thanked Dr JC Rana and the Bioversity International for its financial support for the 1st NCPGRM. He also thanked the Treasurer for excellent financial management and for keeping updated financial records of ISPGR.

Agenda 6: Discussion on Revised Rules and Regulations of ISPGR

- Dr Anuradha Agrawal presented the salient features of the revisions of 'Rules and Regulations of ISPGR', as recommended by an Expert Committee constituted by the EC, and also ratified by the EC (*Annexure 4; Item # 2*).
- The GB appreciated the efforts of the Committee and endorsed the proposed amendments. Accordingly, revised rules shall be published and circulated amongst all members. Also the office of Registrar of Societies shall be kept informed of changes proposed.

Agenda 7: **Any other item**

• Dr Pratibha Brahmi, the recipient of Dr H.B. Singh Memorial Award (2021-22) presented to the President a donation of Rs 50,000 to the Society, as a token of her appreciation for the efforts made towards PGR management and in view of

her long association with the society. The President thanked her for the kind gesture and wishes her a very fruitful life after her superannuation.

• With the permission of Chair, Dr S.K. Kaushik suggested for consideration that out of the two posts of Vice President in the EC, one may be reserved for the Director, ICAR-NBPGR. He was advised to submit his proposal in writing to the EC for further consideration.

Agenda 8: **Remarks by Vice Presidents, ISPGR**

- Dr J.C. Rana appreciated the online system of IJPGR, current financial status of the Society, and the successful organization of 1st NCPGRM, another rolling event of ISPGR, after 1st and 2nd International Agrobiodiversity Conference.
- He also apprised about the regional events planned for 2023-24 including the Seminar on Plant Biodiversity for Food, Nutrition and Health Security in North-West Himalayas in association with Shoolini University, Solan, a PGR Awareness Program for college students at Hyderabad, and possibly a Regional Conference at Umiam, Meghalaya.
- Dr R.K. Tyagi appreciated the transparent and efficient working of ISPGR and EC members under the dynamic leadership of Dr R.S. Paroda. He also gave compliments for the good financial status of the Society. He appreciated the initiatives to be taken by Zonal Councillors for undertaking activities in different regions and sought full support from all members to make future events successful.

Agenda 9: Remarks by Director, ICAR-NBPGR

- Dr G.P. Singh, Director, ICAR-NBPGR appreciated the present status of the membership and financial status of the Society, along with the online publication of IJPGR journal, which may contribute in the ranking/ citation of the Journal.
- He also highlighted the need to build public-private partnership for effective management and sustainable use of PGR thus benefiting both the ICAR-NBPGR and the Society.

Action Taken Report on the $12^{\rm th}$ GBM held on Aug. 20, 2022

	Recommendation	Action Taken
1.	For elevating the stature of IJPGR, including making IJPGR as an open access/hybrid journal, e- publishing, a committee comprising Drs R. K. Tyagi (Chairperson), Anuradha Agrawal (Member), Sunil Archak (Editor-in-Chief, IJPGR & Member), Monika Singh (Member), Kuldeep Tripathi (Member), Kuldeep Tripathi (Member), Manjusha Verma (Member Secretary) was urged to expedite action to provide recommendations for improvement of IJPGR.	 The committee held three meetings and explored the various possibilities of Open Access/Hybrid mode of publication of IJPGR, including financial implications. Options explored were tie-up with ARCC Journals Springer-Nature, Taylor and Francis, ICAR-DKMA M/S MRI Publication and M/S Diva enterprises. Based on the recommendations by the Journal Committee IJPGR has collaborated with the M/S MRI Publication, for online paper processing and journal open access system, and new webpage for IJPGR. The MoU was signed on Sept 7, 2022 and two issues have been published, so far.
2.	The 9th meeting of the Governing Body (GB) of the 'International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA)' was scheduled to be held from Sept. 19-24, 2022. President, ISPGR urged that Society should take active participation in the GB9 for visibility of its varied activities, including issues directly related to the Treaty.	 The Delhi-based EC and other members of ISPGR actively participated in the meeting. Two ISPGR members (Drs Pratibha Brahmi and Sunil Archak) were official delegates of the Indian contingent and Drs Anuradha Agrawal and Vandana Tyagi were included in the Technical Committee supporting the Indian contingent. ISPGR participated in the exhibition held during the meeting.
3.	The need for increasing the number of life members was emphasized. For increasing the membership, members of other related Societies and PGR students need to be encouraged.	 Since last GBM, 75 new life members have been inducted, including PGR and genetics students.
4.	It was suggested that Zonal Councillors take a more pro-active role in not only increasing membership of the Society but also initiating seminar/symposia at regional level.	 One seminar has been planned in Solan during Nov 3-4, 2023. Proposals for one meeting in Umaim and one in Hyderabad are under active planning.

Report of General Secretary, ISPGR

1. Meetings Held

- The last General Body Meeting (GBM) was held on Aug. 20, 2022 and minutes were shared on Sept. 13, 2022.
- Since last GBM, five EC (2022-24) meetings were held on Oct. 3, and Dec. 14, 2022; Mar. 27, Apr. 3, and Aug. 7, 2023 to discuss and decide the various issues related to activities and growth of the Society.
- Based on the decisions and suggestions of above meetings, the activities held are enumerated hereunder.

2. Revision of ISPGR Constitution

- Following Committee for 'Revision of ISPGR Constitution and the criteria for nominations of awards' held its meeting on Oct. 7, 2022:
 - i. Dr B.S. Dhillon Former Vice Chancellor, Punjab Agricultural University (PAU), Ludhiana (Chairperson)
 - ii. Dr Bhag Mal Secretary, Trust for Advancement of Agricultural Sciences (TAAS), New Delhi (Member)
 - iii. Dr R.K. Tyagi Coordinator, Asia Pacific Consortium for Agricultural Biotechnology and Biodiversity (APCoAB), Bangkok (Member)
 - iv. Dr Anuradha Agrawal General Secretary, ISPGR, New Delhi (Member Secretary)

The specific points for deliberations (based on issues raised during earlier GBMs) by the Committee were as follows:

- For all posts of EC, there is restriction of a candidate to apply for a given post for maximum of two tenures [Section 8 (iii) of Rules and Regulations, 2015]. Exception has been made for the posts of President and General Secretary. The Committee needs to review the restrictions in tenure, for the better functioning of the Society in the long run.
- As per Section 8 (iv) of Rules and Regulations, 2015, The Director, ICAR-NBPGR is *Ex-Officio* Member of EC without any voting rights. The Committee to review the *proviso*.
- Should ISPGR continue the traditional methods of postal ballots for voting during elections, or switch to digital/online voting?
- With respect to awards, should the EC members be allowed to apply for awards while holding any post in EC, considering that all awards are approved finally by the EC? Further, the criteria for selection of 'Dr Harbhajan Singh Lifetime Award' has been criticized by a few applicants in the past and needs to be reviewed.

• Any other modification to improve the functioning and transparency of the Society.

A revised draft of constitution was prepared. The major recommendations emerged were:

- Since proforma for all awards were revised in 2020, no further changes were required except for 'Dr Harbhajan Singh Memorial Award', wherein the column for allocation of marks has been removed, to allow for both qualitative and quantitative assessment of the applicant, as it is a prestigous lifetime achievement award.
- With respect to guidelines of all awards, the committee unanimously agreed that EC members should not be eligible to apply for any award while holding any post of the EC.
- With respect to Section 8 (iii) of Rules and Regulations, 2015, all the posts should be open for contesting without any restrictions, as was the provision under the original rules of the Society at the time of its inception. Further, voting rights to be given to the *Ex-Officio* Members, provided they are life member of the ISPGR.
- With respect to mode of elections, ISPGR may follow digital mode of casting votes, given that it saves time and resources. The best software to undertake electronic method of voting to be determined prior to elections, based to the available options which is economical, fool-proof and maintains the required secrecy of votes casted.
- Under Section 13 (Funds and Accounts) Subsection (viii), ISPGR may increase its minimum reserve fund from Rs 5 lakhs to Rs 25 lakhs.
- The EC has recommended that proposed revisions be placed in the 13^{th} GBM for finalization of revisions.

3. ISPGR Awards

- The call for inviting applications for variuos ISPGR was made in Nov. 2022 and last date for receiving nominations was Jan 31, 2023. A total of 44 applications were received for various awards.
- The meeting of **Award Selection Committee** was held on May 17, 2023, in hybrid mode*, at Committee Room, KAB-2, ICAR. The Committee comprised following members:

4. Events Organized

• ISPGR co-organized the National Symposium on 'Food, Nutrition, Health and Environmental Security: Aiming to Achieve SGDs' (organized by TAAS, in collaboration with ISPGR, ICAR, NAAS) from Aug 29-30, 2022. During this sympsium, dedicated to Dr R.S. Paroda on his 80th birthday, TAAS, NAAS, ISPGR and Alliance of Bioversity International & CIAT jointly organized a felicitation function in the evening of 29 August, 2022. On this occasion, a Special issue of IJPGR Vol 35(3), 2022, comprising 80 articles on agrobiodiversity was released. Also a film was made highlighting the major contributions made by Dr R.S. Paroda.

- ISPGR partcipated in the 9th Governing Body Meeting (GB9) of the '**International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA)'** during Sept. 19-24, 2022. The Delhi-based EC and other members of ISPGR actively participated in the meeting. Two ISPGR members (Drs Pratibha Brahmi and Sunil Archak) were official delegates of the Indian contingent and Drs Anuradha Agrawal and Vandana Tyagi were included in the Technical Committee supporting the Indian contingent. ISPGR also participated in the exhibition held during the meeting, where its activities and literature were showcased.
- The 1st National Conference on Plant Genetic Resources Management (NCPGRM) was successfully organized at NASC, New Delhi from Nov 22-24, 2022. A total of 316 participants attended the conference including 197 registered delegates, 89 invited guest and organizers, 9 farmers and 21 participants representing Sponsors. The NCPGRM was organized by ISPGR, ICAR, NBPGR, Alliance for Bioversity International & CIAT and the PPV&FRA. Coorganizers included TAAS, CIMMYT, ICARDA, World Agroforestry, ICRISAT and NAAS. Sponsors included FSII, Hytech Seeds, Mahyco, Kaveri Seeds, Rasi Seeds, NSAI, Imperial Life Sciences, UD Associate, Sim Biochem, Biovis, Elementar and Perkin Elmer. The conference was held in hydrid mode. The program commenced with an inaugural session which was Chaired by Dr Himanshu Pathak, Secretary DARE & DG, ICAR. The Plenary lecture was delivered by Dr R.S. Paroda, President ISPGR. In the five technical sessions, seven keynote lectures and 20 invited lectures were delivered by eminent scientists from India (physical) and abroad (online). Technical sessions also included 8 short lectures from senior scientists and 33 rapid oral presentations from young scientists and students. In all 150 posters were displayed from all the technical session. One panel discussion with eight panelists was also held. Awards were given for best oral presentations (12) and best posters (11) from the various technical sessions. The conference also had a welcome dinner and cultural program on the first day. Overall, participants expressed great satisfaction with the organization of NCPGRM.
- The **ISPGR Award function** held on August 14, 2023 at ICAR-NBPGR, New Delhi.
- The '5th Dr A.B. Joshi Memorial Lecture' entitled "Preserving the Green Sentinels: The imperative of conservation of World's Mangrove Forest Genetic Resources for a sustainable future" was delivered on Aug. 14, 2022 by Dr Sanjay Deshmukh, Former Vice Chancellor, Mumbai University.
