#### Agenda 1: Welcome Remarks

- Dr Anuradha Agrawal, General Secretary, welcomed the Chairman, along with all the members of Executive Council (EC) and General Body (GB), who were present either in person or virtually.
- Dr P.L. Gautam, Past President & Honorary Fellow of ISPGR, appreciated the activities being carried out by the ISPGR, including the just concluded National Conference on Managing Agrobiodiversity in North-Eastern India (NCMAN): From Biodiversity to Bio-wealth (October 23-25, 2024). The 'Umiam Declaration' emerging from the conference would increase the visibility of the Society. He suggested that ISPGR may consider including the words like 'Biodiversity' in its future activities to attract larger number of participants and some activity be conducted by the Society on International Day of Biodiversity on May 22 every year.

#### Agenda 2: Introductory Remarks by Chairman

• While welcoming all GB members, Dr R.S. Paroda, appreciated and acknowledged Dr P.L. Gautam for his constant support in all activities of ISPGR, including the organization of the conferences at Shoolini University (2023) and Umiam (2024). He also appreciated presence of Dr R.C. Agrawal, DDG (Agric. Educ.), ICAR & former Vice-President, ISPGR, Dr Kuldeep Singh, Head Genebank, ICRISAT during the meeting as well as the NCMAN-2024 conference.

# Agenda 3: Confirmation of Minutes of 13<sup>th</sup> GBM, Action Taken Report (ATR) and Progress Report of ISPGR

- The minutes of the 13<sup>th</sup> GBM held on August 14, 2023 were unanimously confirmed and ratified by the GB.
- Dr Anuradha Agrawal, General Secretary, presented the ATR report on the 13<sup>th</sup> GBM (*Annexure 3*), followed by progress report of ISPGR since the last GBM (*Annexure 4*).
- Dr Paroda suggested that ISPGR may conduct a round table discussion to address the public-private partnership issue related to germplasm exchange, germplasm evaluation, partnership for research cooperation and needs of the private sector.

#### (Action: President and General Secretary)

- Dr Kuldeep Singh suggested that there is room for increasing partnership and interaction/collaboration with other related societies/academies for joint activities e.g. ISGPB, Seed Science *etc.* It was suggested that possibly MoUs could be developed with these Societies. This would help in increasing membership. Dr Paroda suggested that some experts from India may represent in the 3<sup>rd</sup> IAC to be held in China during April 22-25, 2025.
- All the participants were appreciative of different activities and thanked the General Secretary for her sincere efforts in executing all activities of ISPGR.

### Agenda 4: Progress of IJPGR by Editor-in-Chief

- Dr R.K. Tyagi, Editor-in-Chief, presented the report related to publication of IJPGR (*Annexure 5*). He apprised the status of manuscripts, and as well as printing schedule and progress, NAAS rating of the Journal, citation in Google Scholar *etc*. With the cooperation of reviewers and editors, the journal is not only updated, but now publishing ahead of its time schedule. Further, all publication steps were now being done fully on the e-publishing platform (https://ispgr.in/index.php/ijpgr) through MRI Publishers.
- The issue of improving the NAAS rating was discussed in detail, with Dr S.K. Sharma suggesting that IJPGR should aim to have NAAS score more than 6.0. Dr R.C. Agrawal suggested that more number of review articles can be invited, especially from eminent scientists in India and abroad. He also suggested that extra efforts be made to increase citation of papers. Dr Kuldeep Singh informed that he has suggested that at least few Indian journals need to be included in applications for NAAS Fellows/ Awards, so that Indian journals get better quality papers. Dr S.K. Sharma also endorsed the view that papers published in national journals also should be included. It was agreed that the matter be discussed in NAAS meeting by the members of ISPGR who are also Fellows of NAAS.

(Action: All concerned)

• The President appreciated the work done by Editor-In-Chief, Editors, Reviewers

and ISPGRstaff for clearing backlog and timely publication of the journal. He appealed that who more committed people need to come forward and take the responsibility of the journal.

• He specially appreciated the efforts made by Dr R.K. Tyagi, Editor-in-Chief for additional work and timely publication of current volumes of IJPGR.

### Agenda 5: Financial Report of ISPGR by Treasurer

- Dr Kuldeep Tripathi, Treasurer, presented financial status of ISPGR, including the audited reports for the FY 2023-24 (*Annexure 6*).
- The GB was pleased to note the healthy financial position of the Society. It was suggested that in future revenue may be generated through priced publications and increased membership drive.
- President thanked Dr J.C. Rana (Bioversity International), Dr Kuldeep Singh (ICRISAT) and ICARDA for financial support for NCMAN. He also thanked the Treasurer Dr Kuldeep Tripathi, for good financial management and for keeping the financial records in an orderly manner.

### Agenda 6: **Any other item**

- Dr Anuradha Agrawal apprised of the forthcoming elections of the EC of ISPGR, which will be completed in an online mode. Dr. Dinesh Kumar, Executive Secretary, Indian Agricultural Universities Association (IAUA) & Former ADG (FFC), ICAR, will be the Election Officer.
- She apprised of the 3<sup>rd</sup> International Agrbiodiversity Congress (IAC) scheduled to take place in China. She also encouraged members of the Society to participate in the event.
- Dr Anuradha also informed that recently NBPGR has asked ISPGR to vacate the rented room in NBPGR. The President advised that necessary steps be taken at the earliest to seek a suitable office space in the society block of NASC and inform NBPGR suitably.

### Agenda 8: Chairman's Address

- Dr R.S. Paroda, President, ISPGR expressed his great satisfaction on the overall activities of the Society.
- He recommended to organise an interface meeting with the private sector to deliberate issues concerning the support for farming community, value-addition through sustainable use of PGR, ABS matters and for consortia approach for sustainable use of genetic resources.

(Action: General Secretary)

• He also recommended to constitute a Committee comprising of the members, Dr

S.K. Sharma, Dr Kuldeep Singh, Dr R.C. Agrawal, Dr R.K. Tyagi (EIC, IJPGR), and Dr Anuradha Agrawal (Member Secretary) for suggesting the ways to improve the rating and quality of publication of IJPGR and other scientific publications. (Action: General Secretary & EIC)

- Dr Paroda congratulated all those who received ISPGR awards in a function held on October 23, 2024 during the inaugural session of NCMAN-2024. He also placed on record his appreciation to the members of Awards Selection Committee. He also appreciated the efforts of General Secretary, Dr Anuradha Agarwal, for her meticulous planning to organise the award function and ensuring the presence of awardees in Umiam.
- Dr Paroda emphasized the need for increasing the number of life members. For increasing the membership, he suggested that the members of other related Societies and the students working in different universities on genetic resources and their use be approached. The zonal councillors could help in this regard. Also each councillor be encouraged to undertake some important initiatives like the excellent role played by Dr Veerendra Verma, ZC in getting this conference organised at Umiam. He also placed on record the support extended by Dr V.K. Mishra, Director, ICAR-RC for NEH and all his staff to organise so successfully this national conference (NCMAN 2024).

The meeting ended with a vote of thanks to the Chair and all GB members by Dr Manjusha Verma, Joint Secretary.

# Action Taken Report on the 13<sup>th</sup> GBM held on Aug. 14, 2023

S. No.	Recommendation	Action Taken
1.	Dr R.S. Paroda, emphasized the need for increasing the number of life members. For increasing the membership, members of other related Societies and PGR students have to be approached. (Action: Treasurer, ISPGR and all Zonal Councillors)	Some 36 new members added since last GBM. Efforts to further increase the number are being made in this conference.
2.	The issue of seeking publication charges for papers submitted to IJPGR was discussed. It was deferred with a recommendation that the same may be discussed and approved later once the NAAS Score of the IJPGR goes above 6.0 point. It was recommended by the GB that fresh consent be sought from Foreign Editors of IJPGR to continue their tenure based on their active and timely review. Also, it was agreed that some new foreign editors be invited in order to improve the visibility and impact of IJPGR. <i>(Action : EIC, IJPGR)</i>	The current IJPGR rating is 5.17, hence no charges are being levied for publication of paper in IJPGR. Foreign authors will be contacted for their consent before IJPGR 38(1) 2025. In accordance their response, new Foreign Editors will be invited.
3.	Dr S.K. Vasal suggested that a special issue of IJPGR may be published for the effective utilization of PGR through public-private partnership. The President also endorsed this view and suggested that an interphase meeting with private sector may be planned in collaboration with ICAR-NBPGR to understand the expectations of private sector from the Society (ISPGR) specially with regard to access-benefit sharing and the resource generation. For this, working group comprising of retired experts in PGR management, persons from private sector, young scientists may be constituted by the EC. ( <i>Action : GS, ISPGR; Director, ICAR-NBPGR and EIC, IJPGR</i> )	<ul> <li>A 'PPP in Agriculture' meeting was organized by TAAS (July 9, 2024) and attended by some ISPGR members.</li> <li>A one-day brainstorming session on ABS is being planned in first quarter of 2025; accordingly Special volume would be planned.</li> </ul>
4.	The GB appreciated the efforts of the revisions by the 'Rules and Regulations of ISPGR Committee' and endorsed the proposed amendments. Accordingly, revised rules shall be published and circulated amongst all members. Also the office of Registrar of Societies shall be kept informed of changes proposed. # **Report of General Secretary, ISPGR**

# 1. Meetings Held

- The 13<sup>th</sup> GBM was held on Aug. 14, 2023. Proceedings were circulated on Sept 20, 2023 and also sent to the Registrar of Societies Office.
- Since the last GBM, five meetings of the EC were held (Nov 17, 2023; Jan 18, 2024; April 29, 2024; July 11, 2024; Sept 18, 2024), to discuss and decide the various issues related to activities and growth of the Society.
- Based on the decisions and suggestions of above meetings, the activities held are enumerated hereunder.

# 2. Events Organized

- The **ISPGR Award function** was held on Aug. 14, 2022, featuring the **5th Dr A.B. Joshi Memorial Lecture** delivered by Prof. Sanjay Deshmukh, Former Vice-Chancellor University of Mumbai, entitled "Conservation of mangroves".
- A National Seminar on Plant Biodiversity for Food, Nutrition and Health Security • in North-West Himalayas (PBFSNWH), was held at Shoolini University, Solan, Himachal Pradesh, Nov. 27-28, 2023. The event was organized in hybrid mode by ISPGR, New Delhi, Shoolini University (SU), Solan, Himachal Pradesh and ICAR-National Bureau of Plant Genetic Resources (NBPGR), New Delhi. The seminar covered a wide range of topics, ranging from the importance of plant biodiversity for food security and nutrition, threats to plant biodiversity, traditional knowledge and practices for using plant biodiversity for food and medicine, conservation strategies, access, exchange, and benefit sharing, entrepreneurship and value addition, role of youth including women and enabling policies on conservation and sustainable use. It brought together over 200 participants, from various organizations including the institutes of ICAR, Alliance for Biodiversity International and CIAT, Central and State Agricultural Universities, Council for Scientific and Industrial Research (CSIR), Defense Research and Development Organization (DRDO), Himachal Pradesh State Government agencies, private stakeholders, and progressive farmers. Over the course of two days, the PBFNWH featured 21 plenary/keynote/invited/evening lectures and 20 rapid oral presentations in the five technical sessions, one Plenary Session, an evening lecture and a Valedictory Session. A concurrent poster session by young scientists, faculty and students showcased some 51 posters. The papers presented at the seminar provided a valuable resource for researchers, policymakers, and practitioners and communities working on plant biodiversity conservation and utilization in the North-West Himalayas (NWH). Proceedings of PBFNWH were published and circulated amongst all concerned.

# 3. ISPGR Awards

The call for awards of ISPGR were announced on October 26, 2023 and widely circulated amongst all ISPGR members, State Agricultural Universities, Central

Universities and research institutes. These included :

# 4. Interim Change of ISPGR Office Bearers

- Dr Sanjeev Singh, **Treasurer, ISPGR,** left NBPGR, New Delhi, and joined as Senior Scientist-cum-Head, KVK Medziphema, Nagaland w.e.f. Oct 3, 2023. As per Constitution of ISPGR, Treasurer needs to be in the Headquarters (Delhi), for smooth functioning of the ISPGR. Accordingly, EC endorsed nomination of Dr Kuldeep Tripathi, Councillor (North Zone), to work as additional charge of Treasurer, ISPGR w.e.f. Nov 2023, till next elections.
- On Nov. 14, 2023, Dr Sunil Archak relinquished charge as **EIC of IJPGR**, which was accepted during 7<sup>th</sup> EC meeting of ISPGR. Thereafter, Dr R.K. Tyagi, Vice-President was nominated by the EC of ISPGR to take additional charge of EIC, IJPGR till a new incumbent was identified.

# 8. Administrative Matters

- ISPGR participated in the NAAS-PAAS (Professional Association of Agricultural Sciences ) meeting held at NAAS on May 31, 2024 and Aug 7-8, 2024. President NAAS informed that the meeting was meant to build close partnership in various scientific and academic activities, especially improving the quality of scientific journals being published by various societies.
- All routine administrative work (Papers to IT office for getting 80G status for ISPGR, room rent, grants application to ICAR) undertaken in timely manner. Accounts of ISPGR audited for the FY 2023-24.
- The ISPGR EC elections for the 16 posts of EC (2025-27) were due as per schedule of ISPGR constitution. Thus, nomination of Election Officer was sought from EC. The elections to be done using electronic voting, as was done last time.
