Agenda 1: Welcome Remarks

• Dr Anuradha Agrawal, General Secretary (GS), welcomed the Chairman, EC members, to the second meeting of the Executive Council (2025-27) and informed about the reasons for inability of absentee EC members. The agenda for the meeting was then introduced (*Annexure 1*).

Agenda 2: Introductory Remarks by Chairman

• Dr R.S. Paroda, President, appreciated the continued commitment of the EC members and emphasized the importance of timely follow-up actions. He highlighted the upcoming scientific events of the Society and stressed that preparations must be expedited for effective visibility of ISPGR. Dr Paroda also mentioned the active participation of ISPGR in the 3rd International Agrobiodiversity Congress (IAC), Yunnan, China (May 20–22, 2025), where ISPGR successfully organized a side event on 'Sustainability Challenges and Options for Farmer-led Initiatives on Community Genebanks'. He emphasized that the first IAC, initiated by ISPGR in 2016 at New Delhi, has created a global momentum, and the continued conduct of IAC by different partners reflects the long-lasting impact of ISPGR's pioneering efforts in this area. He appreciated the role played by the entire Indian contingent during the event.

Agenda 3: Confirmation of the Minutes of First EC (2025–27) Meeting and Action Taken Report

• The Minutes of the First EC Meeting held on March 28, 2025, were placed before the EC by the GS. The Committee unanimously confirmed the Minutes.

- The Action Taken Report (ATR) on decisions of the first meeting was presented by the GS and duly approved (*Annexure II*).
- The General Secretary also presented her Report (*Annexure III*), outlining the 3rd IAC participation, publishing of proceedings of UMiam and Kunming, and the shifting of the ISPGR office. The report was approved by the EC.

Agenda 4: Editor-in-Chief's Report

- Dr R.K. Tyagi, Editor-in-Chief, presented updates on manuscript submissions, review status, and publishing timelines of IJPGR issues scheduled for 2025 (*Annexure IV*).
- The EC appreciated the efforts and approved the report.
- Dr Tyagi informed that Ms Deepshikha Dixit has joined as a part-time Editorial Assistant, in place of Mr Arup Das.
- It was decided that follow-up with the publisher (MRI) may be expedited to strengthen the online submission and publication system.

(Action: Editor-in-Chief and GS).

Agenda 5: Treasurer's Report

- Dr Kuldeep Tripathi, Treasurer, presented the Treasurer's Report, detailing the income, expenditure, and current financial position of the Society (*Annexure V*). The EC expressed satisfaction with the financial management and approved the report.
- The draft Audit Report of ISPGR and NCMAN was presented to the EC (*Annexure VIa,b*). President, ISPGR, suggested that final signed report be placed in the next EC meeting.

(Action: Treasurer)

• Also suitable action be taken for filing of Income Tax returns. Possibility be explored for taking CSR funds in ISPGR by consulting with Chartered Accountant.

(Action: Treasurer and GS)

• The President advised timely action for obtaining ICAR grants for IJPGR (2025–26) as well as the forthcoming symposium.

(Action: Treasurer and GS)

Agenda 6 (a): Nomination of vacant position of Councillor (West Zone)

• Though Dr Vinay Bhardwaj, Director, ICAR- National Research Centre on Seed Spices, Ajmer was proposed to be Councillor (WZ) in the earlier meeting, it could not be approved since he was not a member of the society during the required cut-off date.

• It was suggested to explore any other suitable senior member from the WZ for the position and place the proposal in the next EC meeting.

(Action: GS and Vice President)

Agenda 6 (b): National Symposium on PGR of Western Ghats

- The EC reviewed progress on preparations for the proposed 'National Symposium on Harnessing PGR of the Western Ghats: From Biodiversity Hotspot to Sustainable Bioresource Hub (NSWG)' to be held in December 2025. The concept note was presented to the EC (*Annexure VII*). The EC finalized Dec. 12-13, 2025, as the dates for the proposed National Symposium and reviewed the ongoing preparations.
- Dr Rohini M., Councillor (SZ), informed about initial discussions with ICAR-IIHR, Bengaluru, for hosting the event, and assured to provide a detailed status note shortly.
- Dr Sherry Rachel Jacob, Joint Secretary, will be contact point for the Society, and will
 coordinate and finalize theme areas, in consultation with President, Vice Presidents and GS.
 Dr Sherry Rachel Jacob and Dr Rohini M.R. identified as Organizing and Co-organizing
 Secretaries from ISPGR for the symposium.
- The EC finalized the membership of the Core Organizing Committee and the Technical Program Committee.
- President suggested that suitable and quick action be taken for finalizing the concept note, first circular and draft programme. Letters to patrons, advisory members etc. be sent timely.

(Action: Dr Rohini M. & Dr Sherry R. Jacob)

Agenda 6 (c): National seminar on 'Germplasm Conservation, Management and its Utilization in Vindhyas'

- Dr. Vaidurya Pratap Sahi, EC (CZ), in a letter addressed to President, ISPGR proposed for organizing one-day brainstorming workshop on "Germplasm Conservation, Management and its Utilization in Vindhyas", aimed at raising awareness for our ongoing initiatives in this critical area (*Annexure VIIIa*). Vindhya region which includes southern districts of eastern Uttar Pradesh like Prayagraj, Mirzapur, Sonbhadra etc is rich in agricultural biodiversity, A tenetaive program was also presented (*Annexure VIIIb*).
- After detailed deliberations, President suggested while the proposal was interesting, the focus of the meeting may be reviewed again, especially in terms of in situ conservation of quite rich rice diversity in the region. He suggested that a fresh proposal be made as further discussed.

Agenda 7: Remarks by Vice Presidents

• Dr R.C. Agrawal appreciated the initiatives of the ISPGR and offered full support in the organization of the forthcoming symposium at Bengaluru.

• Dr R.K. Tyagi suggested that there was need to expedite the preparations for the symposium and agreed to draw the first draft for technical program. He also appreciated the role played by ISPGR in the 3rd IAC held in Kunming, China.

Agenda 8: Remarks by President

• Dr R.S. Paroda urged all members to maintain momentum on society activities, including the preparedness for Western Ghats symposium. He appreciated the efforts made in bringing out all the publications, especially the proceedings and recommendations of Umiam conference and Side event at IAC.

The meeting ended with a vote of thanks to the Chair and all EC members by the Dr Anuradha Agrawal, General Secretary.

Based on a request received through email, it was decided that Dr Sandeep Kumar, Principal Scientist, Division of Germplasm Evaluation, ICAR-NBPGR, New Delhi may be nominated as Councilor (North Zone). Dr Vinay Bhardwaj, Director, ICAR-National Research Centre on Seed Spices, Ajmer was proposed by Dr Anuradha Agrawal for the post of Councilor (West Zone). Both the nominations were unanimously approved by the EC members present. Formal letter may be sent to the nominees and both Dr Sandeep Kumar and Dr Vinay Bhardwaj be informed accordingly. Report of General Secretary, ISPGR

- Minutes of 1st EC meeting were circulated on April 10, 2025. No comments were received and minutes placed in 2nd EC for approval.
- A large contingent (13) from India participated in the 3rd International Agrobiodiversity Congress held in Kunming, China during May 20-22, 2025. These comprised ISPGR EC Members (Drs R. S. Paroda, R.K. Tyagi, Anuradha Agrawal and Kuldeep Tripathi) and Members (Drs Kuldeep Singh, J.C. Rana, Sanjeev Singh, Mahesh Rao, Vetriventhan Mani, Padma Gore). The congress comprised 6 technical sessions, with 10 keynote lectures, 31 oral presentations, 6 panel discussions. A poster session of 200 posters was also held, besides 17 side events and an exhibition with 16 stalls. In all 1000 participants from 58 countries participated in the 3rd IAC. Dr R.S. Paroda, President, spoke during the inaugural session of the Congress on the 'Road from Delhi-Rome-Kunming'. Dr Anuradha Agrawal, General Secretary, participated in the thematic session on 'Agrobiodiversity for Healthy Diets from Global Perspectives' as a Panel Discussant. DR Kuldeep Tripathi, Treasurer, made a presentation on 'The Stress Tolerant Orphan Legumes (STOL) Consortium: Efforts towards mainstreaming orphan legumes in India and Africa'.
- A Side Event (S14, T6) titled "Sustainability Challenges and Solutions for Farmer-led Initiatives on Community Genebanks" was organized during the 3rd IAC on 21 May 2025 in Kunming, Yunnan, China. The session was co-hosted by the ISPGR, New Delhi; Alliance of Bioversity International and CIAT, India Office, New Delhi; M.S. Swaminathan Research Foundation (MSSRF), Chennai, and Trust for Advancement of Agricultural Sciences (TAAS), New Delhi. Deliberations were held on the growing sustainability challenges faced by community genebanks and explored innovative, farmer-centric solutions that support their long-term sustainability. The session brought together about 40 policymakers, scientists, practitioners, students and farmer representatives for knowledge exchange and collaboration. The proceedings and recommendations have been published and soft copy is placed on the ISPGR website.

- The 'Umiam Declaration on Managing Agrobiodiversity in North-Eastern India' adopted in the 'National Conference on Managing Agrobiodiversity in North-Eastern India (NCMAN)-From Biodiversity to Bio-wealth', held during Oct. 23-25, 2024, have been published and also placed in the ISPGR website.
- The last date of receiving applications of ISPGR awards was extended up to June 30, 2025. A total of 49 applications were received for the five ISPGR award categories. These are being processed for screening by the selection committee.
- Since Jan 2024, action was initiated to request ICAR space for ISPGR office in NASC Office Block A (earlier occupied by PPVFRA). After concerted efforts, two rooms (26 and 18) have been allotted (*Annexures III a and b*).
- After repair and renovation of the rooms, ISPGR offices have shifted to the new premise in August 2025. The new address of the ISPGR is as follows:
